Re: Invitation to Project TOTO Meeting

Dear Commissioner Rossotti,

On Saturday, February 17th, 2001, at the Crystal City Hilton Hotel in Arlington, Virginia, about 400 people from many parts of the country will meet to discuss a multi-million dollar, nationwide plan to expose and end the illegal operations of the income tax system.

Respectfully, we would like to invite you, or Mr. Mark Matthews, Mrs. Dale Hart or another expert from the IRS to attend the meeting. We realize this is short notice, and we had not intended to invite IRS people to this particular meeting, but in view of the recent comments by Mr. Matthews and Mrs. Dale, published in the NY Times last Saturday, that the IRS was starting a "crackdown," we are sending this invitation to send expert representatives to the meeting to tell us about the IRS's position, or to tell us when the IRS will send representatives to a conference to discuss and debate and respond to the allegations by tax researchers that there is no law. The NY Times article and the "crackdown" obviously have been timed to be published just before our meeting, so we feel justified in sending you this invitation at what would normally be considered a late date.

We realize that you or your officials would not want to spend the whole day with us. Probably no more than an hour would be sufficient.

The meeting is being organized by individuals from several groups who have been working together over the last several months to plan, prepare and



execute a large, coordinated, nationwide, multi-media public information campaign ("Project TOTO"). The goal is to educate scores of millions of citizens (along with accountants, tax attorneys, legislators, judges, IRS employees, and prospective jurors) about the true nature of the income tax laws, to expose operations of the IRS that are unauthorized by law, and to put an end to their illegal collection of taxes from people who do not owe them — the vast majority of US citizens. We will present the plan for this multi-million dollar project that will utilize nationwide electronic, print and broadcast media to put detailed documentation before the public.

This meeting comes as a result of the agency's continued evasion of the allegations of fraud and illegal operations of the income tax system, including the following: 1) There is NO LAW that requires most Americans to file a tax return, pay the federal income tax nor have the tax withheld from their earnings; 2) In 1913, the 16th Amendment (the "income tax" Amendment) was fraudulently and illegally declared to be ratified by a lame-duck Secretary of State just days before leaving office; 3) Those people who file a Form 1040 "voluntarily" waive their 5th Amendment (Miranda) right not to bear witness against themselves; 7) The IRS routinely violates citizens' 4th Amendment rights against illegal search and seizure without a warrant issued by a court upon probable cause and supported by oath and affirmation. IRS levies and seizures are unenforceable because the IRS is UNABLE AND UNWILLING to swear under oath that a law has been broken or that there is probable cause of a violation; 4) The IRS, as standard operating procedure, routinely violates citizens' due process rights in its administrative procedures and operates far outside the law and that the courts cannot be relied upon to strike down such actions.

We would like to invite you to attend the meeting to comment upon some of the allegations which have been presented to you by Joseph Banister, William Benson, William Conklin and by this organization during the last two years, and to explain the agency's position, or to attend long enough to at least tell the group assembled when the experts at the IRS would be available to meet with tax researchers in a public forum to explain where they are in error and to show them the law that requires most Americans to file a tax return and to have the income tax withheld from the money they earn.
